Professional & Staff Services \$300.00

If the cremated remains are claimed before they are interred, the deposit will be refunded.

DISBURSEMENTS

Disbursements are items arranged for and possibly paid for on your behalf by us. You are expected to pay for these items at the time that a contract is entered into. The following are some of the items often identified as disbursements.

Coroner's fee

This is a fee charged by the coroner for issuing the certificate that allows the cremation to take place. The fee is set by the Chief Coroner of Ontario.

Newspaper Notices

This is a fee charged for death notices placed in newspapers.

Municipal Death Registration Fee

This is a fee charged by the local municipality to register the death. The fee is set by the municipality and it may vary.

Bereavement Authority of Ontario Consumer Protection Fee

The fee is charged by the Bereavement Authority of Ontario (BAO) in order to provide its services of information on your options in bereavement services and to regulate the profession making sure the law is consistently followed. Please read the BAO's free Consumer Information Guide on its website or in print (offer printed copy to anyone who wants it). The BAO's regulatory work includes responding to public complaints, inspecting and providing guidance to bereavement businesses and professionals, which it licenses across Ontario to better serve you – the public. The BAO is wholly funded by licensee fees (not tax dollars).

We will arrange cremation with any crematorium, but we suggest Cataraqui Cemetery Crematorium. Price varies by crematorium. Alternatively we can arrange aquamation with Wartman Funeral Home Inc.

Payment, Financing and Funding

Payment: Unless otherwise specified, payment is due upon completion of services. Payment may be made by cash, cheque, e-transfer, Mastercard or Visa (surcharge of 4% for Visa or Mastercard will be added). Payment plans are also available to meet most budgets. Beyond the allotted time, interest will be charged at a rate of 1.5% per month which is the equivalent to 18% per annum (APR). If you are prepaying for services or supplies, pre-authorized debit is also available.

Funding: When prepaying, you pay for the services and supplies today and the money will be used to pay for the services and supplies when they are used at the time of death. The money paid to us will place it into trust, where it will accrue interest until the contract is fulfilled (when the services and supplies are delivered) and the contract is executed.
